ALEXANDRE DUMONT

Father and Son?

Few family legends are more in conflict than those of the Gueret--Dumonts of Douglas County, OR. The present material may lay bare some issues but add one or two more.

The legend, as reported by Harriet Duncan Munnick, has Alexander Dumont from Three Rivers Canada trapping in the South Umpqua area in the 1820s with one Joseph? Xavier? Lavadour--both with Pend d'Oreille wives. (1) Munnick concluded the date was much too early inasmuch as Dumont had declared he was an American half-breed, born in Green Bay, Wisconsin in 1815, moving to Oregon in 1836. (2) The picture is further blurred by the death record of Andrew Dumont, son of Alexander, from information supplied by Andrew's son, Sam, in 1922. This named Alexander's birthplace as St. Louis, Michigan. (3) The 1870 Oregon Federal census lists Alexander, age 58, indicating possible birth in 1812.

The St. Louis, MI information does not hold since the town had no existence before 1859; before that time the area was known as Pine River.(4) It is curious, however, that a mixed-blood family, the Gruets, settled in the St.Louis area. The similarity of names may have led a researcher astray. The town of St. Louis is but a few miles south of the Isabella Chippewa Reservation. There is no relationship established between the two families even though the original Gruet, Joseph, father of Jacques (James), and our Alexander Gueret both served out of Michillmakinac (Mackinaw) in the Old Northwest.

One Alexandre Dumont of La Noraye (Lanoraie) in the judicial district of Trois-Rivières was an engagé for the firm of Rocheblave and Porlier, well known at Mackinaw, to go to the "sud des Pays d'en Haut." Although his residence was at Lanoraie, Alexandre was baptized at nearby St. Sulpice on September 13, 1779---not unusual given the French-Canadian custom of baptism as soon as possible after birth. His contract was drawn before the Notary Louis Chaboillez March 12, 1803. (5) The citation translates the "southern part of the Upper Country". In the early days Upper Country could refer to any place upriver from Montreal beyond Ste. Anne de Bellevue------Bout de l'île (Isle's End). In the fur trade the southern part would often mean below Mackinaw---north of there gave rise to the term "homme

du Nord". The northener considered himself above the relatively easier assignments and recruits whom they termed the "mangeurs de lard" or pork belly (salt pork) weaklings. Rocheblave and Porlier was active in the Lac du Flambeau and headwaters of the Mississippi region.

Nothing is known of Dumont's activities in the region. In 1803 Wisconsin was part of Indiana Territory becoming part of Illinois Territory before the 1810 federal census. The census for Indiana 1800 is lost as well as th 1810 Illinois Territory for St. Clair County which woul have included Green Bay. By 1820 Green Bay, Brown County, was part of Michigan Territory. Neither the 1820 or the 1830 Michigan federal census has any listing for Gueret or Dumont. Wisconsin did not become a territory until 1836.

Is there any way to establish Alexandre Gueret-Dumont, 1803 engage, at Green Bay? Fortunately, in 1857 an elderly long time resident of the area, Augustin Grignon, dictated his recollections to Lyman Copeland Draper, head of the State Historical Society of Wisconsin, and placed Alexandre Dumont at Green Bay before and after the War of 1812.(6)

The 1803 engage, Alexandre Dumont II, was the son of Alexandre Gueret "dit" Dumont who married Marie-Brigitte Aubin-Paradis February 9, 1778 at Lanoraie. Our subject, Alexander III, born in 1812 or 1815 was the father of Alexander IV, baptized July 23, 1839 at Colvile, WA by Father Modeste Demers. The father's name was given as Louis and the mother as Josette Finlay---most subsequent references to the couple identify the male spouse as Alexandre. In 1803 Alexandre II was 24, the 20s were the most usual ages for recruiting engages. Still, one François Victor Malhoit who captained at Lac du Flambeau in 1804-5 entered the fur trade at 15 as an articled clerk.

There is no record of Alexandre's return to Quebec evidenced by a marriage there. The Pacific Northwest historical records refer to the wife of Alexander, Josette Finlay, sometimes as metisse Cree or Spokane or Pendd'Oreille. Alexandre, a $\frac{1}{2}$ blood, identified his mother as Sauteau or Salteaux, a branch of the Ojibways, the latter sometimes corrupted to Chippewa. The Sauteaux were numerous around the Sault Ste. Marie area.

The report of Alexandre Dumont (III?) trapping and trading in the Milo (Umpqua country) region in 1828 (7) would have a youth of 13 teamed with a partner, Joseph Lavadour, some 24 years his senior. If Dumont was

born in 1812 rather than 1815 he would have been 16. There have been reports of strapping boys in their mid-teens working at the fur trade.

A plausible explanation might be Alexandre III was old enough to accompany his father, Alexander, then 49, as a partner with Lavadour about 37. There is support for this in the DAR record for Lavadour Cemetery (8) affirming that one Alexander Dumont, about 112 years, was known to have been buried there. It is not likely the deceased was 112 but if the first burial was a grandson, Auguste, buried in 1868, Alexandre II would then be 89. The Lavadour Cemetery Alexandre would not be our subject Alexandre III sine the pair went to the Colvile country for their last years while Lavadour went to the Umatilla.

Was Alexandre II part of Malhoit's group at Lac du Flambeau in 1804-5? No mention is made of him in Malhoit's journal. One Alexis Duma was engaged to go there in 1807 from Mackinaw. There is nothing to indicate this was Alexandre Dumont; however the records of engagements for the West compiled by the Archivist of Quebec has no listing for any Alexis. The Dumas were another family which gave members to the trade.

If the Gueret-Dumont family group moved to the Pacific Northwest some explanation might be needed. A possible might be the War of 1812. In a letter from M. Irwin, U. S. Factor, to Colonel John Bowyer, Indian Agent, July 24, 1817 a list was submitted of British subjects at Green Bay, hostile to the United States. Alexandre Dumont is not on this list. The military was seeking a site at Green Bay to locate a fort. Irwin reported the area was "Mongrel French" and destitute although it was a relatively prosperous community before the conflict. (10)
